Criteria for admission¹

Inclusion in the World Market Leader Index is based on objective and transparent selection criteria. Companies must fulfill the following requirements, among others:

- Regionally rooted, globally active: At least 50% of the head office must be located in the DACH region.
- International presence: Activities on at least three continents with own production and/or sales companies.
- Economic strength: A minimum turnover of 50 million euros per year.
- Market leadership: 1st or 2nd place in the relevant global market segment.
- Export orientation: At least 50% of sales from abroad.

SEEBURGER fulfills all of these requirements. Since its foundation in 1986, the company has been headquartered in Bretten, Baden-Württemberg. The company has always been family-owned and today has 27 locations in 16 countries worldwide. SEEBURGER generates 53% of its turnover abroad and records annual sales growth of 10%.

Technology and flexibility as success factors

The SEEBURGER Business Integration Suite (BIS) Platform is a key success factor for the company. The platform covers various operating and deployment models, including license purchase, subscription, iPaaS and fully managed services. Customers can choose between different operating environments, including private clouds, hyperscalers such as AWS, GCP and MS Azure, or hybrid models.
